Shri/Smti/Miss Gope Tao is hereby appointed temporarily to officiate as Senior Teacher (Geography) in the PB-2 of Rs. 9300-34800 + GP Rs. 4800/- PM plus other allowances as admissible under rules from time to time with effect from the date he/she actually reports for duty to the Principal, Government Higher Secondary School, Chiyangtajo, East Kameng District of Arunachal Pradesh.

The appointment is made against newly created post vide order No.ED3/252/10-11 dated 09.08.2010.

The appointment shall be on probation for a period of 2(two) years w.e.f. the date of joining. His/her continuation beyond probation period of 2(two) years shall be subject to the satisfactory performance during probation period.

The appointment is subject to the following conditions:-

1. The appointment is pure temporary and may be terminated at any time by giving 1(one) month notice. If he/she wants to resign, he/she may do so after giving one month notice or by surrendering one month salary.
2. The confirmation of service shall be considered on completion of probationary period subject to the satisfactory performance of duty.
3. After joining duty, he/she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
4. The appointment is subject to Police Verification and he/she will be dismissed from service if any adverse report is found against him/her with immediate effect.
5. On joining, the appointee shall have to serve for a minimum period of 3(three) years at the place of posting.
6. The seniority of the appointee shall be based strictly on merit list.
7. The appointment order shall be cancelled if the appointee directly or indirectly campaign for change of posting place or does not join within 20(twenty) days from the date of issue of this order at posting place.

The other terms and conditions of service which are not specified herein shall be governed by the relevant rules in force from time to time.
