ORDER

In pursuance of Govt. approval, Sri George Darang is hereby appointed temporarily as Primary Teacher (PRT) on Compassionate Ground in the Pay Matrix Level-06-Cell-01 of Rs 35,400/-PM. plus other allowances as admissible under rules from time to time with effect from the date he/she reports to concern DDSE, Changlang District.

The appointment shall be on Compassionate Ground as Govt. of India, Ministry of Home Affairs Order No. 1404/20/90 Estt. (D) Dated 09/12/93.

The appointment is made against the vacant post of Shri Rasheswar Saikia PRT (Rtd).

The Appointment is subjected to the following conditions :-

1. The appointment is purely temporary and may be terminated at any time giving 1(One) Month Notice. If he/she wants to resign, he/she may do so after giving one monthly notice or by surrendering one month salary.
2. The confirmation of service will be considered on completion of probationary period subject to satisfactory performance of duty.
3. After joining duty he/she will have to produce Medical Fitness Certificate from an Authorized Medical Officer.
4. The regularization is subject to Police Verification and he/she will be dismissed from service if any adverse report is found against him/her with immediate effect.
5. After joining duty, He/She will have to take Oath of an Allegiance of affirmation to the Constitution of India in prescribed form.
6. On joining , the appointee shall have to serve for minimum period of 3 (three) years at the place of posting.
7. The other terms and condition of service which are not specified herein shall be governed by the relevant rules in force from time to time.
