- The appointment is purely temporary and may be terminated at any time without assigning any reasons after serving one month notice. If he/she wants to resign may require to give one month notice or surrender one months salary.
- After joining in the duty he/she shall have to take an Oath of allegiance of affirmation to the constitution of India in the prescribed form.
- He/She will have to produce medical fitness certificate in prescribed form from an authorised medical officer.
