The engagement is made vice resignation/expire / not joined of Shri/Smt. Mrs
(STATISSA) (Applicable in case of resultant vacancies).

The engagement is subject to the following conditions:-

- a) The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- b) No Earned leave is permissible except casual leave as per Central Govt. General Leave Rule and as per terms and condition mentioned in the agreement only.
- c) During contract service period he/she is not entitled for medical reimbursement, winter allowances, children educational allowance, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowance etc.
- d) The contract teacher have to report his/her duty at posting place within 7(seven) days from the date of joining in the office of the concerned DDOE cum DDC, failing which his/her engagement order will automatically be treated as cancelled.
- e) He/she is not entitled to subscribe GPF or CDF or such other schemes during the period of contract services.
- f) The engaged teacher is also to work as volunteer instructor for TLC programed for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- g) No representation will be accepted for change of posting place.
- h) He/She will have to under gone DDEI training at various DDEI for Training and when call for.
- i) The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force from time to time.
- j) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
