ORDER

Miss Nabam Yata is hereby engaged as Trained Graduate Teacher (TGT) on contract basis in the fixed pay of **₹34,855.00 (Rupees Thirty Four Thousand Eight Hundred Fifty Five) only** with effect from the date of joining in the concerned school up to 31/03/2022 against Centrally Sponsored Scheme of Samagra Shiksha, ISSE. She is posted at **Govt. Res. School, Chessa-I.**

The engagement is made vice resignation / expire / waiting panel / not joined of Shri/Smt., TGT / PRT (Application in case of resultant vacancies).

This order issue as per administrative approval of the competent authority of Samagra Shiksha ISSE, Arunachal Pradesh, Itanagar vide Order No. **AR/ISSE/ESTT/AA/149(PP)/2020-21/437-40** Dated **24/08/2021**.

The engagement is subject to the following conditions:-

- a. The Contract Teacher has no right to claim for regular appointment / regularization of the post after expiry of contact engagement.
- b. No Earned Leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditions mentioned in the agreement copy.
- c. During contract service period he/she is not entitled for medical reimbursement; winter allowances; children education allowance; reimbursement of tuition fees; leave travel concession (LTC); Special compensatory allowance etc.
- d. The contract teacher have to report his/her duty at posting place within 7 (seven) days from the date of joining in the office of the concerned Administrative Officer, failing which his/her engagement order will automatically be treated as cancelled.
- e. He/She is not entitled to subscribe GPF or CGIS or such other schemes during ht eperiod of contract service.
- f. No representation will be accepted for change of posting place.
- g. He/She will have to undergo for DIET training at concerned DIET as and when call for.
- h. The validity of contract period is upto 31/03/2022 which may be extended by seeing the performance / regularity of teacher as recommended by concern SMC.
- i. The other terms and conditions of service which are not specified shall be governed by the relevant rules and other in forced time to time.
- j. The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
