School - Raga, Lower Subansiri, Arunachal Pradesh.

- · The appointment is made vice Shri Braja Rakhal Banik, TGT, retired.
- The appointment is subject to the following conditions:-(2)
- The appointee shall be on probation for a period of 2(two) years w.e.f. the date of joining and their seniority will be fixed as per the overall merit.
- The appointment is purely on temporary and may be terminated at any time by giving 1(one) (ii) month notice without assigning any reason thereof. If he / she wants to resign, he or she may do so after giving 1(one) month notice or by surrendering 1(one) month salary.
- The regularization of service shall be considered on completion of probationary period subject to (iii) satisfactory performance of duty in his/her initial place of posting.
- After joining duty, he / she will have to take an oath of allegiance of affirmation to the Constitution (iv) of India in the prescribed form.
- He / she will have to produce Medical Fitness Certificate from an authorized Medical Officer. (v) ·
- The appointment is Subject to the Police Verification and he / she will dismissed from government (vi) service if any adverse report is there with immediate effect.
- He / she shall remain in the place of posting for a minimum period of 3 (three) years from the date of joining. No representation / campaigning for the change of posting place shall be entertained before completion of 3(three) years of service in the initial place of posting.

Other terms & conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.
