- (d) The appointment is subject to the Police Verification and he/she will be discharged from service with immediate effect if there be any adverse remarks against him/her in the Police report.

The appointment are for a probation period of 3 years. If the work and conduct of the teacher is not found satisfactory, he/she may be terminated.
