Primary/ Middle/ School. Up to HOnel Year against the centrally sponsored scheme of SSA.

The engagement is subject to the following conditions

a) The contract teacher has no right to claim for regular appointment / regularization of the post after expiry of contract period.

b) No earned leave is permissible except casual leave as per central civil service leave rule and as

per terms and condition mentioned in the agreement copy.

During contract service period he/she is not entitled for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC), special compensatory allowances and any other such allowances
