Shri/ Smti/Sri Lam Tekseng is here engaged as J/1/ APT on contract basis in the fixed pay of Rs.26,453 /-(Rupees Twenty six thousand four hundred fifty three) only with effect from the date of joining in the concerned district upto 2016-17 against centrally sponsored scheme of Sarva Shiksha Abhiyan. He/ she is posted at Primary/ Upper Primary School/Govt. Sec. School Patasing

The engagement is subjected to the following conditions:


- The contract teacher has no right to claim for regular appointment/ regularization of the post after expiry of contract engagement.
- No Earn Leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
- During the contract service period he/ she is not entitle for Medical reimbursement, winter allowances; children educational allowances; reimbursement of tuition fees; leave travel concession (LTC); special compensatory allowances etc.
- The second party shall be entitling for drawl salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in Training, Bridge Course and any other departmental engagement.
- The contract teacher have to report his/ her duty at posting place within 7 (seven) days from the date of joining in the office of the concerned DDSE, failing which his/ her engagement order will automatically be treated as cancelled
- He /she is not entitle to subscribe GPF for CGEIS or such other scheme during the period of contract services.
- The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in additional to his/ her normal duties.
- No representation will be accepted for change of posting place.
- He/ she will have to undergone DIET Training at concerned DIET for training as and when call for.
- The other terms and condition of services which are not specified shall be governed by the religion rules and order in forced time to time.
- The engaged teacher has to sign an Agreement for contract engagement before receiving this engagement order.
