- (h) The appointment order shall be cancelled if the appointee directly or indirectly campaign for change of posting place or does not join within 10 (ten) days from the date of issue of this order at posting place.

The other terms and conditions of service which are not specified herein shall be governed by the relevant rules in force from time to time.
