- a) The contract teacher has no right to claim for regular appointment / regularization of the post after expiry of contract period.

b) No leave is permissible except casual leave as per central civil service leave rule and as per terms and conditions mentioned in the agreement copy.

c) During contract service period he/she is not entitled for medical reimbursement, winter allowances; children educational allowances; rembursement of tuition fees; leave travel concession (LTC); special compensation allowing allowances and any other such allowances.

d) The contract teacher have to report his/her duty at posting place within 7(Seven) days from the date of joining in the concerned DBSEs office failing which his/her engagement order will automatically be treated as cancelled.

e) He/she is not entitled to subscribe GPF / CGEIS or such other schemes during the period of contract services.

f) The engaged teacher is also to work as volunteer instructor of TLC / PLP programme for the interest of the community in Auroorchal Pradesh in addition to his/her normal duties. Further the engaged teacher is also bound to perform any other duty assigned by the State Govt / District Administration / Education Department in any addition to his/her normal duties.

g) No representation will be accepted for change of posting place.

h) He/she will have to undergo DGET training at concerned DGET for training as and when called for.

i) The other terms and conditions of services which are not specified shall be governed by the relevant rules / Orders / Guide lines / instructions in force time to time.

j) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
