

ORDER

**Shri Karik Megu** is hereby appointed temporarily as **Laboratory Assistant** on compassionate ground in the Pay in the Pay Matrix Level-6, Cell-1 of Rs. 35400/- p.m. plus other allowances as admissible under rules from time to time with effect from the date he / she actually reports for duties to the Principal, IGJ Govt. - After joining duty, he / she will have to take an oath of allegiance of affirmation to the Constitution of India in the prescribed form.
- He / she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- The appointment is Subject to the Police Verification and he / she will be dismissed from government service if any adverse report is there with immediate effect.
