The appointee shall be on probation for a period of 2 (two) years with effect from the date of issue of order. His/Her continuation beyond probation period for 2 (two) years shall be subject to satisfactory performance during probation period.

The Appointment is subject to the following conditions:-

- 1. The salary will be drawn from the date of his/her joining in the duty.
- 2. The Appointment is purely temporary and may be terminated at any time by giving 1(one) month notice. If he/she wants to resign, he/she may do so after giving one month notice or by surrendering one month salary.
- 3. The regularization of service will be considered on completion of probation period subject to satisfactory performance of duty.
- 4. After joining duty he/she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- 5. The appointment is subject to Police verification and he/she will be dismissed from service if any adverse report is found against him/her with immediate effect.
- 6. After joining duty he/she will have to take Oath of an allegiance of affirmation to the Constitution of India in the prescribed form.
- 7. On joining, the appointee shall have to serve for a minimum period of 3 (Three) years at the place of posting.
- 8. The seniority of the appointee shall be based strictly on their date of joining.
