

## // APPOINTMENT ORDER //

Teacher (TGT)** Mathematics/ Science/ Social Science/ Language (English/ Hindi)/ **Primary Teacher (PRT)** on contract basis in the fixed pay of Rs 15,000/- (Rupees Fifteen Thousand Only only w.e.f. 1<sup>st</sup> April 2022 under **Namsai District** up to **01 (one) year** against centrally sponsored scheme of Integrated Scheme for School Education (ISSE) Samagra Shiksha. He/She is posted at GHSS/GSS/GUPS/GPS GSS Namsai.

**The Engagement is subject to the following conditions:-**

1. The contract employee has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
2. No earned leave is permissible except 12 days casual leave as per Temporary Central Civil Service Leave Rule.
3. The mark sheets/certificates submitted by his/her for consideration are subject to verification from original source. In case of the forged mark sheets/certificates he/she is liable to face legal action as per CCS Rule.
4. During contract service period he/she is not entitled for medical reimbursement, winter allowances, children education allowances, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowances etc.
5. The engaged employee is also to work as volunteer instructor of TLC/PLP programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties. Further the engaged is also bound to perform any other duty assigned by the State Govt. /Dist. Administrator/Education Department in any addition to his/her normal duties.
6. The contract employee have to report for his/her duty at posting within 7(seven) days, failing which his/her appointment order will automatically be treated as cancelled.
7. He/she is not entitled to subscribe GPF/CGEIS or such other schemes during the period of contract services.
8. No representation will be accepted for change of posting place.
9. The other terms and conditions of service which are not specified shall be governed by the relevant rules/orders/guidelines/instruction in force time to time.
10. The engaged employee has to sign an agreement for contract agreement before receiving this appointment order.
11. His/ Her contractual service will remain valid for 01 (one) year and thereafter it will be treated automatically terminated and a fresh renewal will be required.
