- b) After joining the duty he/she shall have to take an Oath of allegiance or affirmation to the constitutions of India in the prescribed form.
- c) He/she will have to produce Medical fitness Certificate in prescribed form from an authorised Medical Officer.
- d) The appointment is subject to Police Verification and he/she will be dismissed from Govt. Service if any adverse reports are there with immediate effect.
- e) The other terms and condition of services which are not specified herein, shall be governed by the relevant rules and order's in force from time to time.
