DEED OF AGREEMENT FOR CONTRACT ENGAGEMENT UNDER S.S.A

This agreement is made and executed on this.....^{27th}..... day of ^{Jan}..... Two thousand eleven (2011) between the District Project Officer, Sarva Shiksha Abhiyan, Lower Dibang Valley District, Roing which expression shall and ^{Sri} / ^{Smti} / Miss.....^{MIDINY, TAYENY}..... hereafter the second party.

Where as the *Sarva Shiksha Abhiyan* Authority, District Lower Dibang Valley has approval in public interest and in exigency of service, the engagement of second party as ^{A.I.T}....., on contract basis, under the District Project Director, and the second party has agreed to serve the *Sarva Shiksha Abhiyan* on the terms and conditions hereafter contained that:-

1. This contract service shall be for the period 2011-12 only commencing from the date of joining at the place of posting and ending at the end of the academic session / contract period i.e. on **2011 - 2012**.
2. (i) The Second party shall have no right to claim for regularization of the services rendered on contract basis. The period of service rendered on contract basis shall not be counted for any other purpose too.
(ii) The Second party, in the event of his/her getting barred by age for any other employment during the currency of the contract services shall not claim for regular appointment in the post now offered to her on contractual basis.
3. (i) The second party will be entitled consolidate fixed pay of ^{20,800/-}.....
(^{Rupees Ten thousand eight hundred only}) only per month as mentioned in the order during the period of the contract.
(ii) Dearness Allowances:- No dearness allowances or any other allowances will be paid to the second party during the period of contract service.
(iii) TA & Daily Allowances:- The second party will be entitled to TA/DA for the period of absence from headquarter on official duties supported by Govt. orders as per rules applicable to other regular Govt. employees.
(iv) TA & DA at the time of appearing in the interview and for joining in the service is not permissible.
(v) The second party will not be entitled to joining time pay. In fact the service of the second party will be counted from the date of joining in the institution/office for purpose of his/her pay.
(vi) The second party will not be entitled for any kind of leave other than the casual leave.
4. During the period of currency of the contract service, the duties, responsibilities and conduct of the second party shall be governed by statutory rules in force of Govt. of Arunachal Pradesh.
5. The Second Party shall not be entitled to any terminal benefits under the pension rules for the period spent on **CONTRACT SERVICE** under this agreement.
6. The Second Party is not entitled to subscribe to GPF or CGEIS of such other welfare scheme during the period of contract service.
7. The second party shall be entitled for drawing of salary only for the **working days** within the academic session / contract period only. Salaries for vacation period shall be drawn only when they are engaged in training, Bridge Course and any other departmental engagement.
