## ORDER

Miss Odi Taki is hereby engaged as J/T on contract basis in the fixed pay of Rs.8500/- (Rupees eight thousand five hundred) only with effect from the date of joining in the concerned school upto 30/04/2009 against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. The posting will be made after the completion of 30 (thirty) days induction training.

The engagement is subject to the following conditions -

- a) The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- b) No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule as per terms and condition mentioned in the agreement copy.
- c) During contract service period he/she is not entitle for medical reimbursement; winter allowances, children educational allowances; reimbursement of tuition fees, leave travel concession (LTC); special compensatory allowances etc.
- d) The contract teacher have to report his/her duty at posting place within 7 (seven) days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- e) He/she is not entitled to subscribed GPF or CGEIS or such other schemes during the period of services.
- f) The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of Interacy in Arunachal Pradesh in addition to his/her normal duties.
- g) No representation will be accepted for change of posting place
- b) He'she will have to under gone DIET training al concern DIET for Training as and when call for
- i) The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.
- The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
