ORDER

In pursuance of Govt. approval vide C.O No. 511 Dated 09/03/2016 the following candidates are hereby regularized temporarily as Primary Teacher (Assistant Teacher (A)) in the scale of pay PB 2-9100-14800 + GP 4200 + PM, plus other allowances as admissible under rules from time to time with effect from the date they reports for duty to DDSE, Jamin, Kra Daadi District.

2. The regularization shall be on probation for a period of 2 (two) years w.e.f the date of joining. His/her continuation beyond probation period for 2 (two) year shall be subject to satisfactorily performance during probation period.

The regularization is subjected to the following conditions:-

1. The regularization is purely temporary and may be terminated at any time by giving 1 (one) month notice. If he/she wants to resign, he/she may do so after giving on month notice or by surrendering on month salary.
 2. The confirmation of service will be considered on completion of probationary period subject to satisfactory performance of duty.
 3. After joining duty he/she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
 4. The regularization is subject to Police Verification and he/she will be dismissed from service if any adverse report is found against him/her with immediate effect.
 5. After joining duty he/she will have to take Oath an allegiance of affirmation to the Constitution of India in the prescribed form.
 6. On joining, the appointee shall have to serve for a minimum period of 3 (three) years at the place of posting.
 7. On their regularization as Primary Teacher (AT-A) they should undergo compulsory in-service DIET/DPE/B.Ed. within 3 (three) years failing which their appointment order shall be cancelled.
3. The other terms and condition of service which are not specified herein shall be governed by the relevant rules in force from time to time.
