3. The officer shall be on probation for a period of 2(two) years with effect from the date of joining. His/her continuation in service beyond probation period of two years is subject to satisfactory performance during probation period.

4. The appointment is subject to the following conditions :-

- a) The appointment is purely temporary and may be terminated at any time without assigning any reasons. If he/she want to resign he may do so after giving one month's notice or by surrendering one month pay.
- b) After joining the duty he/she shall have to take on Oath of allegiance of affirmation to the constitutions of India in the prescribed form.
- c) He/she will have to produce Medical fitness Certificate in prescribed form from an authorised Medical Officer.
- d) The appointment is subject to Police Verification and he/she will be dismissed from Govt. Service if any adverse reports are there with immediate effect.
- e) The other terms and condition of services which are not specified herein, shall be governed by the relevant rules and order's in force from time to time.

5. Shri/Smti/Miss Parantia Petra

shall have to continue for a minimum tenure of 3(three) years terms in his present posting place.

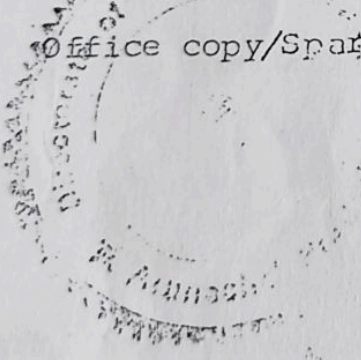
