Miss Pune Perme is hereby appointed temporarily to officiate as Assistant Teacher (A) in the PB-2 of Rs.5500-34800+GP, Rs. 4200-PM plus other allowances as admissible under rules from time to time with effect from the date he actually reports for duty to the Headmaster, Govt. Middle School, Riew, East Siang District under DSE, Pasighat, Arunachal Pradesh.

The appointment is made against Shri Yawna Rado, AT (A) Promoted to J.Pron (暫) post.

The appointment shall be on probation for a period of 2 (two) years w.e.f. the date of joining. His/her continuation beyond probation period for 2 (two) years shall be subject to satisfactory performance during probation period.

The appointment is subject to the following conditions:-

7. The seniority of the appointee shall be based strictly on merit list.
8. The appointment order shall be cancelled if the appointee directly or indirectly campaign for change of posting place or does join with 20 (twenty) days from the date of issue of this order at posting place.
