ORDER

Sri Bined Libang S/O Sri Ilo Libang is hereby engaged as Asstt. Teacher on Contract basis in the fixed pay of Rs. 10800/- (Rupees Ten thousand eight hundred) only with effect from the date of joining in the concerned school/office for the academic session/contract period 2010-11 against centrally sponsored scheme of Sarva Siksha Abhiyan. He is posted at Govt. P. S. Paglam Checkgate.

The engagement is subject to the following conditions:-

1. The contract teacher/employee has not right to claim for regular appointment/regularization of the post after expiry of contract employment.
2. Except casual leave no other leave is admissible as per norms.
3. During contract service period he/she is not entitle of medical reimbursement; winter allowances; children educational allowances; reimbursement of tuk tuition fees; leave travel for vacation period etc.
4. The second party shall be entitled for drawal of salary only for the academic session/contract period. Salaries for vacation period of teachers shall be drawn only when he/she is engaged in training, bridge course and any other departmental engagement.
5. His/her service period will be counted from the date of joining in the duties.
6. He/she is not entitled to subscribed GPF or COEIS or such other schemes during the period of contract service.
7. The engaged Teacher is also to work as volunteer instructor for TLC Programme in the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
8. No representation will be accepted for change of posting place.
9. The engaged teacher will have to underge DIET training at concerned DIET for training as an when call for.
10. The employee has to sign an agreement for contract engagement before receiving his/her engagement order.
11. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.
