The engagement is subject to the following conditions:

- The engaged teacher has no right to claim for regular appointment / regularization of the nature of contract period.
- The engaged leave is permissible except service leave as per central civil service leave rule and as per terms and condition mentioned in the agreement copy.
- Leave: contract service period holder is not entitled for medical reimbursement, winter allowances, children educational allowance, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowances and any other such allowances.
- The engaged teacher have to report his/her duty in posting place within 7 days from the date of posting in the concerned D.D. office before which his/her engagement order will automatically be treated as cancelled.
- The duty is not entitled to arrears (DA / DFBS or such other schemes) during the period of contract period.
- The engaged teacher will also work as volunteer in support of H.C. / P.P. programmes for the interest of service in Arunachal Pradesh as assigned to his/her normal duties. Further the engaged teacher should perform any other duty assigned by the State Govt./ Dist. Administration/ Education Department in any reference to his/her normal duties.
- The engagement will be accepted for change of posting place.
- The engaged teacher will continue D.D.T. working at concerned D.D.T for training as and when called by the concerned D.D.T and condition of service which are not specified shall be governed by the relevant rules / Guidelines / Instructions in force from time to time.
- The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
- The contract period will terminate only up to _____ and thereafter it will be treated as automatically terminated and a fresh contract would be required.
- The engaged teacher will have to report for duty in his/her posting place positively on _____ His/her duty will be taken only after putting joining report through the concerned A.P.O. / A.D. _____
