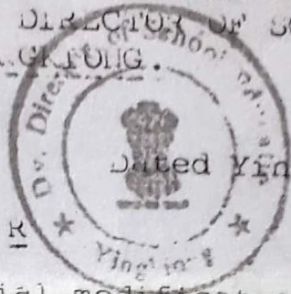



- The appointment is subject to Police Verification and he/she will be dismissed from Govt. Service if any adverse reports are there with immediate effect.

3. The other terms and condition of services which are not specified here in, shall be governed by the relevant rules and order's in force from time to time.

4. Shri/Smti/Miss Nokto Itso shall have to continue for a minimum tenure of 3(three) years term in his present posting place.
