Shri/Smti/Miss. Maloni Tamuk is hereby appointed temporarily as Junior Teacher (Male) in the post of Rs. 9500-3400 + GP Rs. 4800/- per month and other allowances as admissible under rules from time to time with effect from the date he/she actually reports for duty to the DSE/Headmaster, Govt. Secy., Shri/Smti Meete Hiba, Junior Teacher promoted to Headmaster.

The appointment shall be on probation for a period of 02 (two) years and the date of joining may/for continuation beyond probation period for 02 (two) years shall be subject to satisfactory performance during probation period.

The appointment is subject to the following conditions:

- (i) The appointment is purely temporary and may be terminated at any time by giving 14(14) months notice. If he/she wants to resign, he/she may do so after giving one month notice or by surrendering one month salary.
- (ii) The continuation of service will be considered on completion of probationary period subject to satisfactory performance of duty.
- (iii) After joining duty he/she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- (iv) The appointment is subject to Police Verification and he/she will be dismissed from service if any adverse report is found against him/her with immediate effect.
- (v) After joining duty he/she will have to take an oath of allegiance or affirmation to the Constitution of India in the prescribed form.
- (vi) On joining, the appointee shall have to serve for a minimum period of 02 (two) years at the place of posting.
- (vii) The seniority of the appointee shall be based strictly on merit list.
- (viii) The appointment order shall be cancelled if the appointee absents or leaves unexcused for change of posting place or does not join within 10 (ten) days from the date of issue of the order of posting place.

The other terms and conditions of service which are not specified herein shall be governed by the relevant rules in force from time to time.
