ORDER

Shri/Smty/Miss Akup kena is hereby appointed as JT/AT (A) on contractual basis in the fixed pay of Rs. 21175/- (Rupees Twenty one thousand one hundred seventy five) only per month against the resultant vacancy of Shri/Miss Oni Tari who resigned/ expired/ non joining from the post of JT/AT. Under the west siang district with effect from the date of joining in the concern place of posting under SSA.

The appointment is subject to the following conditions:-

1. The contract teacher has no right to claim for regular appointment/ regularization of the post after expiry of the contract engagement.
2. No earned leave is permissible except casual leave as per the central civil service leave rule and as per terms and conditions mentioned in the agreement copy.
3. During contract service period he/she is not entitled for medical reimbursement, winter allowances, children education allowance, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowance etc.
4. The contract teacher have to report his/her duty at posting place within 10 (ten) days from the date of joining in the office of the concern DDSE cum DPO, failing which his/her engagement order will automatically be treated as cancelled.
5. He/ she is not entitled to subscribe GPF or CGEIS or such other scheme during the period of contract services.
6. The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
7. No representation will be accepted for change of posting place.
8. He/she will have to undergo DIET training at concern DIET for training as and when call for.
9. The other terms and condition of services which are not specified shall be governed by the relevant rules and order in force from time to time.
10. The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.


