Shri Takar Nguse (Read upto Class XII) is hereby appointed temporarily to officiate as ~~Assistant~~ Assistant Teacher Grade 'D' under the Directorate of Public Instruction, Govt. of Arunachal Pradesh, and posted to B.S.B. Changlang for ~~undergoing training for one year in the scale of pay of Rs. 260-6-290-ES-8-326-2-366-ES-8-390-1C-400/-p.m. plus other allowances as admissible under rules from time to time with effect from the date on which he reports for duty to the Principal, BSB, Changlang.~~

2. The appointment is subject to the following conditions :-
  - (a) The appointment is purely temporary and may be terminated at any time without assigning any reason after giving one month's notice from either side.
  - (b) After joining duty he will have to take an oath of allegiance or give an affirmation to the Constitution of India duly in the prescribed form before an officer.
  - (c) He will have to produce a medical certificate from a medical officer to the effect that he is fit for Govt. ~~XXXXXX~~ service.
3. The appointment is subject to the police verification and he will be discharged from service with immediate effect if there be any adverse remarks against him in the police report.
4. The other terms and conditions which are not specified herein would be governed by the rules and other order that may be in force from time to time.
