SHRI SAMBHU NATH MONDAL is hereby appointed as ASSISTANT TEACHER in place of MISS AMPI KURU A/T, Govt. Pry. School Zedua under District Project Officer SSA Zilla Mission Longding on contractual basis in the fixed pay of Rs. 21,175/- (Rupees Twenty One Thousand One Hundred Seventy Five) only per months with effect from date of joining against centrally sponsored scheme of Sarva Shiksha Abhiya and he is posted to Govt. Hr. Sec. School Wakka under Wakka Block. The appointment is subject to the following terms and conditions:-

- 1) The contractual service has no right to claim for regular appointment/regularisation after expiry of contract appointment.
- 2) No earn leave is permissible except casual leave as per central civil service rule and as per terms and conditions.
- 3) During the contractual service period he/she is not entitle for medical re-imbusement, Winter Allowances, Children's Education Allowances, Re-imbusement of Tuition fees, Leave Travel Concession (LTC) Special Compensatory Allowance etc.
- 4) The contractual service have to report His/her duty at posting place within 7 (seven) days from the date of joining the office of District Project Officer, Longding. Failing which his/her appointment order will be automatically be treated as cancelled.
- 5) He/ She is not entitled to subscribe GPF or CGEGIS or such other schemes during the period of contract service.
- 5) The appointed contractual service is also to work as volunteer instructor for TLC/PLP programme for the interest of literacy in Arunachal Pradesh in addition to His/her normal duties
- 7) No representation will be accepted for the changing of posting place.
- i) The other terms and conditions of the service which are not specified shall be governed by the relevant rules and order enforce in time to time.


