In pursuance of SPD, Itanagar letter NO. AR/SSA/ESTT/APPTT-01/2017-18 DTD. 18<sup>th</sup> Sept/2017 Ms. Miseng Rekhung is hereby appointed as TGT on contract basis in the fixed pay of Rs. 26,453/- (Rupees Twenty-six Thousand Four Hundred Fifty-three) only with effect from the date of joining in the School against Centrally Sponsored Scheme of **Sarva Shiksha Abhiyan**. She is posted at Govt. Upper Primary School, Changlang Town.

**The appointment is subject to the following conditions:-**

- a) The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract appointment.
- b) No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule as per terms and condition mentioned in the agreement copy.
- c) During contract services period he/she is not entitle for medical reimbursement , winter allowances, children educational allowances, reimbursement of tuition fees, leave travel concession(LTC), special compensatory allowances etc.
- b) The Second Party shall be entitled for drawal salary of only for the academic session. **No work No pay policy** is enforced to the second party.
- d) The contract teacher have to report her duty at posting place within 7(seven) days from the date of joining in the office of the DDSE, failing which his/her engagement order will be automatically be treated as cancelled.
- e) He/She is not entitle to subscribed GPF or CGEIS or other schemes during the period of contract services.
- f) The appointed teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- g) No representation will be accepted for changing of posting place.


- h) He/She will have to under gone DIET training at DIET Changlang for training as and when call for.
- i) The other terms and conditions of services which are not specified shall be governed by the relevant rules and orders in forced time to time.
- j) The appointed teacher has to sign an agreement for contract before receiving this engagement order.
