ORDER

Smti Mongoli Pangkam, is hereby engaged as JT, on contractual basis against the resultant vacancy of Shri Tamaying Mize, JT (SSA) of E/Siang district in the fixed pay of Rs.26453/- (Twenty-six Thousand Four Hundred Fifty-Three) only with effect from the date of joining in the concerned district upto academic session against centrally sponsored scheme of Sarva Shiksha Abhiyan.

The engagement is subject to the following conditions:-


- a) The contract teacher has no right to claim for regular appointment/ regularization of the post after expiry of contract engagement.
- b) No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
- c) During contract service period he/ she is not entitled for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); Special compensatory allowances etc.
- d) The Second party shall be entitled for drawal salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, Bridge course and any other departmental engagement.
- e) The contract teacher have to report his/ her duty at posting place within 7 (seven) days from the date of joining in the office of the concerned DDSE, failing which his/ her engagement order will automatically be treated as cancelled.
- f) He/ she is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract services.
- g) The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his/ her normal duties.
- h) No representation will be accepted for change of posting place.
- i) He / she will have to under gone DIET training at concern DIET for Training as and when call for.
- j) The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.
- k) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.

ORDER

No. ED.2/DSE/290/APT/2015: Shri/Shri/Smti Tamaying Mize is hereby appointed temporarily to the post of Post Graduate Teacher (English) in the Pay Band-2 of Rs. 9300-34,800 + GP-Rs. 4800/- P.M. and other allowances as admissible under rules from time to time with effect from the date he / she actually report for duties to the Principal, Govt. Hr. Sec. School, Anini, Dibang Valley District, Arunachal Pradesh.

The appointment is made vice Shri P.D Bhatt, PGT(English), promoted to HM/VP.

(2) The appointment is subject to the following conditions:-

- (i) The appointee shall be on probation for a period of 2(two) years w.e.f. the date of joining and their seniority will be fixed as per the overall merit.
- (ii) The appointment is purely on temporary and may be terminated at any time by giving 1(one) month notice without assigning any reason thereof. If he / she wants to resign, he or she may do so after giving 1(one) month notice or by surrendering 1(one) month salary.
- (iii) The regularization of service shall be considered on completion of probationary period subject to satisfactory performance of duty in his/her initial place of posting.
- (iv) After joining duty, he / she will have to take an oath of allegiance of affirmation to the Constitution of India in the prescribed form.
- (v) He / she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- (vi) The appointment is Subject to the Police Verification and he / she will be dismissed from government service if any adverse report is there with immediate effect.
- (vii) He / she shall remain in the place of posting for a minimum period of 3 (three) years from the date of joining. No representation / campaigning for the change of posting place shall be entertained before completion of 3(three) years of service in the initial place of posting.

Other terms & conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.
