The appointment is subject to the following conditions:-

1. The contract teacher has no right to claim for regular appointment/regularisation of the post after expiry of contract engagement.
2. No Earned Leave is permissible except casual leave as per Central Civil Service Rule as per terms and conditions mentioned in the agreement copy.

1. During contract service period he/she is not eligible for regular reimbursement, study allowances, children educational allowances, reimbursement of travel, house rent, staff expenses (SIS), special compensatory allowances, etc.
2. The appointed teacher have to report his/her duty at posting place within 07 (Seven) days from the date of issuing in the office of concerned school failing which his/her appointment order will be treated as cancelled.
3. He/she is not allowed to hold dual (DPT or CTEI) or such other schemes during the period of contract.
4. The appointed teacher is also to work as volunteer instructor for TIC programme for the interest of literacy in Agricultural Pradesh in addition to his/her normal duties.
5. No representation will be accepted for change of posting place.
6. He/she will have to undergo DPT training at concerned DPT for training as and when call for.
7. The appointed teacher will teach all subjects in the Govt. Primary School from in any capacity.
8. The commencement and extension of the services of the appointed teacher contract at the end of a financial year shall be subject to the approval of the constitution of the Project (Samagra Shiksha) by MHRD, Govt. of India and the subsequent extension period will be subject to Satisfactory Performance in duty.
9. The appointed teacher shall be on the basis of "No work No Pay". Salary shall be paid only for the academic session. No salary will be paid for vacation period.
10. The appointed teacher has to sign an agreement for contract engagement before receiving this engagement order.
11. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force from time to time.
