The appointment is subject to the following conditions:

1. The contract teacher has no right to claim for regular appointment/regularisation of the post after expiry of contract engagement.
2. No Earned Leave is permissible except casual leave as per Central Civil Service Rule as per terms and condition mentioned in the agreement copy.

1. During contract service period he/she is not eligible for regular recruitment under Government of Assam educational structure. Management of teacher shall be done through TSC (Special Recruitment Structure).
2. The contract teacher have to report to his/her staff of posting place within 07 (Seven) days from the date of posting in the office of concerned school failing which his/her appointment order will be treated as canceled.
3. He is not required to submit Bond or CCA or such other documents during the period of contract.
4. The appointed teacher is also to work as substitute teacher for TSC programme for the duration of 11 months in designated schools in addition to his/her normal duties.
5. His designation will be as regard his posting place.
6. May the post have to undergo DPE training or regular DPE for training as per when call for.
7. The appointed teacher will teach all subjects in the Govt. Primary School/level in any capacity.
8. The continuation and extension of the services of the appointed teacher contract at the end of a financial year shall be subject to the approval of the Headmaster of the Project Samagra Shiksha by District Head of State and the subsequent extension period will be subject to satisfactory performance in duty.
9. The appointed teacher shall be on the basis of "To work as Per". Salaries shall be paid only for the稼働する期間. His salary will be paid for vacation period.
10. The appointed teacher has to sign an agreement for contract engagement before receiving their engagement order.
11. The other terms and conditions of services which are not specified shall be governed by the relevant rules and orders in force time to time.
