He/she is posted at Govt. Middle School Seram..

The engagement is subject to the following conditions :-

- The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule as per terms and condition mentioned in the agreement copy. hi
- During contract service period he/she is not entitle for medical reimbursement; winter allowances; children educational allowances; reimbursement of tuition fees; c) leave travel concession (LTC); special compensatory allowances etc.
- The contract teacher have to report his/her duty at posting place within 7 (seven) days from the date of joining in the office of the concerned DDSE, failing which d) his/her engagement order will automatically be treated as cancelled.
- He/she is not entitled to subscribed GPF or CGEIS or such other schemes during the c) period of services.
- The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties. 1)
- No representation will be accepted for change of posting place.
- g) He/she will have to under gone DIET training at concern DIET for Training as and h) when call for.
- The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.
- The engaged teacher has to sign an agreement for contract engagement before j) receiving this engagement order.
