in prescribed form from an authorised Medical Officer.

4) The appointment is subject to Police Verification and  
he/she will be dismissed from Govt. Service if any  
adverse reports are there with immediate effect.

which are not specified herein, shall be governed by the  
relevant rules and order's in force from time to time.

shall have to continue for a minimum tenure of 3(three) Years  
term in his present posting place.

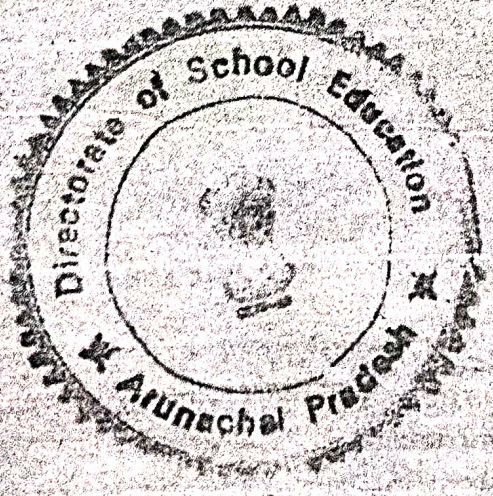
