ORDER

Shri / Smt Ngyadara Mantaw is hereby engaged as  
Assistant Teacher on contract basis in the fixed pay of Rs 7200.00 (Rs. Seven Thousand Two Hundred) only  
With effect from the date of joining in the Govt. Primary/ Middle/ School  
C.O. 244, Deshpande Date 17/04/08 under the centrally sponsored scheme of SSA.  
Kamjong (Lohit) P.S. School.  
The engagement is subject to the following conditions.

- a) The contract teacher has no right to claim for regular appointment / regularization of the post after expiry of contract period.
- b) No earned leave is permissible except casual leave as per contract civil service leave rule and as per terms and condition mentioned in the agreement 2007.
- c) During contract service period teacher is not entitled for medical reimbursement; winter allowances; children educational allowances; reimbursement of tuition fees; leave travel concession (LTC); special concession allowances and any other such allowances.
- d) The contract teacher have to report to the concerned office within 7(seven)days from the date of joining in the concerned office failing which further engagement order will automatically be treated as cancelled.
- e) He/she is not entitled to receive the JWC / EXEM of such other schemes during the period of contract services.
- f) The engaged teacher is also to work as voluntary assistant of TLU / XLF programme for the interest of literacy in Arunachal Pradesh in accordance with the rules. Further the engaged is also bound to perform any other duty as may be assigned by the State Govt./ Dist. Administration/ Education Department in any notified area for any of the above.
- g) No representation will be made by the engaged teacher for promotion.
- h) He/she will have to work in the concerned office as and when called for.
- i) The other terms and conditions of the contract not mentioned shall be governed by the Relevant rules / Orders of the Government of India / Arunachal Pradesh.
- j) The engaged teacher has to report to the concerned office before receiving this engagement order.
- k) His/her contractual service will be terminated if he/she is absent for more than 15 days and thereafter it will be treated automatically terminated and he/she will not be re-engage.
- l) He / She will have to report the duty status to the concerned office positively in \_\_\_\_\_ His / her Pay will be drawn only after getting joining report through the concerned / P.O (AE) / A D E O
