ORDER

Shree Ranjit Kumar Sah is appointed as TGT (Hindi) under KGBV, Kharsang run by Arunachal Orphan Care Society, Kharsang, Miao circle, Dist. Changlang (A.P.). This appointment will be effected from the date of joining in KGBV, Kharsang Dist. Changlang (A.P.) and the appointment is purely on temporarily/contract basis and liable to be terminated at any time without assigning any reason/ground. Moreover, his/her continuation of service will be based on his /her performance/sincerity/punctuality and dedication. The above appointee is directed to submit his/her joining report to undersigned within 7(seven) days from the date of issue of this order and falling of compliance will lead to cancellation of his/her appointment order.

The engagement is subjected to the following conditions: -

1. The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
2. No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditions mentioned in the agreement copy.
3. During contract service period he/she is not entitle for medical reimbursement, winter allowances, children educational allowances, reimbursement of tuition fees, leave ravel concession(LTC), special compensatory allowances etc.
4. The second party shall be entitled for drawl of salary only for the academic session. Salary for vacation period shall be drawn only when they are engaged in training, Bridge course and any other departmental engagement.
5. The contract has to report his duty at his/her posting place within 7(seven) days from the date of joining in the office of the concern DDSE, failing which his/her engagement will automatically be treated as cancelled.
6. He/she is not entitled to subscribe GPF or CGEIS or such other schemes during the period of contract services.
7. The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
8. No representation will be accepted for change of posting place.
9. He/she will have to undergo DIET training at concern DIET centre for training as and when called for.
10. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force time to time.
11. The selected teacher has to sign " Deed of Agreement" for contract appointment before receiving this appointment order.
12. Appointment shall be on the basis of "No work no Pay"
