ORDER.

In pursuance of Govt. approval vide U.O No. 513 dated 06/12/10, Miss Yalek Mize, CI-XII passed is hereby appointed as temporarily to the post of Asst. Teacher (A) on compassionate ground in the scale of pay of Rs. P/B-2-9300-34000-4200/- p.m. plus other allowances as admissible under Rules from time to time with effect from the date he / she actually reports for duties at Govt. Primary School, Miglung under the disposal of DDSE, Pasighat.

The appointment is made on compassionate ground as per the Govt. of India Ministry of Home Affairs order No. 1404/20/90 Estt.(D) dated 09/12/93. He / She is appointed against the vacancy of Sri Sangey Norbu, A/T (A) selected to S.L.

The appointment is made subject to the following conditions:-

- a) The appointment is on probation for a period of 3(Three) years. During probationary period, his / her services may be terminated at any time without any notice or assigning any reason. The regularization of service will be considered on completion of probationary period subject to satisfactory performance of duty.
- b) After joining duty, he / she will have to take on Oath of allegiance of affirmation to the constitution of India in prescribed form.
- c) He / She will have to produce Medical fitness certificate from an authorized Medical Officer.
- d) The appointment is subject to the Police verification and he/ she will be dismissed from service, if any adverse report is there with immediate effect.
- e) On their appointment as a Assistant Teachers they should undergo compulsory in-service DPE/B.Ed. within 3 (Three) years failing which their appointment order shall be cancelled in the light of RTE Act .

The other terms and conditions which are not specified here would be governed by the rules and order that may inforce from time to time.
