ORDER

Chowk Shiksha Bhawan, Miao, No. KEMPI ROTU is herein engaged as Assistant Teacher on contract basis in the first pay of Rs. 10,800.00/- Rupees Ten Thousand Eight Hundred only with effect from the date of joining in the School of Govt. Jr. Sec. School, Lathang I/p u/s 11(6)(c) Year against the centrally sponsored scheme - CCE.

The engagement is subject to the following conditions.

- a) The contract teacher has no right to claim for regular appointment / regularization of the post after expiry of contract period.
- b) No earned leave is permissible except casual leave as per central civil service leave rule and as per terms and condition mentioned in the agreement copy.
- c) During contract service period he/she is not entitled for medical reimbursement; winter allowances; children educational allowances; reimbursement of tuition fees, leave travel concession (LTC); special compensatory allowances and any other such allowances.
- d) The contract teacher have to report his/her duty at posting place within 7 (seven) days from the date of joining in the concerned DDMC's office failing which his/her engagement order will automatically be treated as canceled.
- e) He/she is not entitled to subscribe GPF / CGPS or such other schemes during the period of contract services.
- f) The engaged teacher is also to work as volunteer instructor of TLE / PLP programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties. Further the engaged is also bound to perform any other duty assigned by the State Govt./ Dist. Administration / Education Department or any officials to him/her normal duties.
- g) No representation will be accepted for change of posting place.
- h) He/she will have to undergo poor DIET training at concerned DIET for training as and when required.
- i) The other terms and conditions of services which are not specified shall be governed by the relevant rules / Orders / Guide lines / Instructions in force time to time.
- j) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
- k) His/Her contractual service will remain valid till commencement of Summer Vacation w.e.f. 16th May'2011 and thereafter it will be treated automatically terminated and a fresh renewal would be required for the next academic session.
- l) He/ She will have to report for duty at his / her posting place positively on His/ Her Pay will be drawn only after getting income report through the concerned A.D.E.O of the block.
