- 2. The confirmation of service will be considered on completion of probationary period subjected to satisfactory performance of duty.

- 4. The regularization is subjected to police verification and he/she will be dismissed from service if any adverse report is fund against him/ her with immediate effect.
- 5. After joining duty he/she will have to take Oath an allegiance of affirmation to the Constitution of India in the prescribed form.
- 6. On joining the appointee shall have to serve for s minimum period of 3(three) years at the place of posting.
- 7. The regularization order shall be cancelled if the appointee directly or indirectly campaign for change of posting place or does not join within 15(Fifteen) days from the date of issue of this order at posting place.
- 8. On their regularization as Primary Teacher (AT-A) they should undergo compulsory in service DPE/D.El.Ed./ B. Ed. within 3 (three) years failing which their regularization order shall be cancelled.

The other terms and condition of service which are not specified herein shall be governed by the relevant rules in force from time to time.
