ORDER

Miss Rachel Taluk is hereby engaged as CT on contractual basis against the PGS section of 2010-11 under E Siang district at the fixed pay of Rs. 7200/- (Rupees Seven Thousand Two Hundred) only with effect from the date of joining in the concerned district upto academic session against centrally sponsored scheme of Sarva Shikshak Abhiyan. She is posted to Govt. PS Uting, Siang district.

The engagement is subject to the following conditions:-

- a. The contract teacher has no right to claim for regular appointment regularization of post after expiry of contract engagement.
- b. No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
- c. During contract service period he/she is not entitle for medical reimbursement, winter allowances, children educational allowance, reimbursement of tuition fees, leave travel concession (LTC), Special compensation allowances etc.
- d. The Second party shall be entitled for drawn salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, Bridge course and any other departmental engagement.
- e. The contract teacher have to report his/her duty at posting place within 7 (seven) days from the date of receipt of this order. If he/she fails to do so, his/her contract will be terminated as cancellation.
- f. He/she is not entitled to subscribed GPF or CGPS or such other schemes during the period of contract services.
- g. The engaged teacher is also to work as volunteer instructor for TLE programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- h. No representation will be accepted for change of posting place.
- i. He/she will have to undergo DIET training at concern DIET for Training as and when call for.
- j. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.
- k. The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
