ORDER

Shri Katem Jamoh, is hereby engaged as A/T on contractual basis against the PAB scheme of 2010-11 under E/Siang district in the fixed pay of Rs.7200/- (Rupees Seven Thousand Two Hundred) only with effect from the date of joining in the concerned district upto academic session against centrally sponsored scheme of Sarva Shiksha Abhiyan. He is posted to Govt. PS Sido, East Siang district.

The engagement is subject to the following conditions:-

1. The contract teacher has no right to claim for regular appointment/ regularization of the post after expiry of contract engagement.
2. The contract leave is permissible except casual leave as per Central Civil Service Leave Rule and as per conditions and conditions mentioned in the agreement copy.
3. During contract service period he/ she is not entitled for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); Special compensatory allowance etc.
4. The contract party shall be entitled for drawal salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, Bridge course and any other departmental engagement.
5. The contract teacher shall report his/ her duty at posting place within 7 (seven) days from the date of joining in the office of the concerned DDSE, failing which his/ her engagement order will automatically be treated as cancelled.
6. The contract teacher shall not participate in any other schemes during the period of contract engagement.
7. The contract teacher shall not work as voluntary contractor for TLE programme for the interest of literacy in Arunachal Pradesh or elsewhere in his/ her contract period.
8. No representation shall be accepted for change of posting place.
9. The contract teacher shall be liable to attend the training as and when call for.
10. The terms and conditions of service which are not specified shall be governed by the relevant rules and orders of Government of India.
11. The contract teacher shall sign an agreement for contract engagement before receiving this engagement order.
