ORDER

Shri Katen Jamohi, is hereby engaged as A/T on contractual basis against the PAB scheme of 2010-11 under E/Siang district in the fixed pay of Rs.7200/- (Rupees Seven Thousand Two Hundred) with effect from the date of joining in the concerned district upto academic session against centrally sponsored scheme of Sarva Shiksha Abhiyan. He is posted to Govt. PS Sido, East Siang district.

The engagement is subject to the following conditions:-

1. The recruited teacher has no right to claim for regular appointment/ regularization of the post after expiry of contractual engagement.
2. The teacher leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditions mentioned in the agreement copy.
3. During contractual service period he/ she is not entitle for medical reimbursement; winter allowances; children education allowance; reimbursement of tuition fees; leave travel concession (LTC); Special compensatory leave etc.
4. The recruited teacher shall be entitled for drawal salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, Bridge course and any other departmental assignments.
5. The recruited teacher upon to report his/ her duty at posting place within 7 (seven) days from the date of joining, in the office of the concerned DDSE, failing which his/ her engagement order will automatically be treated as terminated.
6. The Govt. in its discretion may withdraw TSPY or CGPS or such other schemes during the period of contract engagement.
7. The engaged teacher is obliged to work as volunteer conductor for TLL programme for the interest of literacy in Arunachal Pradesh in addition to his/her assigned duties.
8. The engagement period is 1 year starting from the date of joining and when call for.
9. The rights, terms and conditions of services which are not specified shall be governed by the relevant rules and orders of concerned Government.
10. The engaged teacher has to sign an agreement for present engagement before receiving this engagement order.


