## ORDER

## The Appointment is subjected to the following conditions:-

- The appointment is purely temporary and may be terminated at any time giving 1( One ) Month Notice. If he/she wants to resign, he/she may do so after giving one monthly notice or by surrendering one month salary.
- The confirmation of service will be considered on completion of probationary period subject to satisfactory performance of duty.
- After joining duty he/she will have to produce Medical Fitness Certificate from an Authorized Medical Officer.
- 4. The regularization is subject to Police Verification and he/she will be dismissed from service if any adverse report is found against him/her with immediate effect.
- 5. After joining duty, He/She will have to take Oath of an Allegiance of affirmation to the Constitution of India in prescribed form.
- 6. On joining, the appointee shall have to serve for minimum period of 3 (three) years at the place of posting.
- 7. The other terms and condition of service which are not specified herein shall be governed by the relevant rules in force from time to time.
