Further, their continuation in service will be subject to the following conditions:-

- a) Successful completion of basic training.
- b) True and sufficient disclosure of information by them while filling up each and every column of the attestation form.
- c) Satisfactory verification of character and antecedents. On verification, if any adverse remarks are received regarding character and antecedents, their services will be terminated forthwith.
- d) The appointment is purely temporary and may be terminated at any time without assigning any reason(s) thereof.
- e) They are required to serve at least for 3 years in the Department from the date of joining, unless they are discharged or dismissed or certified by a Civil Surgeon to be unfit for such service. If the individual resigns before the expiry of the said three years, he has to refund the cost of training, i.e. pay drawn during the period of training plus the expenses of TA to join the training school.
- f) They will be on probation for a period of two years.
- g) The persons appointed are required to serve in Civil Police in any place in the districts of Arunachal Pradesh where they are posted and detailed.
- h) Their inter-se seniority shall be fixed as per merit obtained at the time of recruitment.
- i) No TA/DA will be admissible to join the Training Centre.
- j) The CCS (Pension) rule -1972 and GPF rules shall not be applicable to them.
