The appointment is made subject to the following conditions :-

1. The appointment is purely temporary and may be terminated at any time by giving 1 (one) month notice. If he/she want to resign, he/she may do so after giving one month notice or by surrendering one month salary.
2. The confirmation of service will be considered on completion of probationary period subject to satisfactory performance of duty.
3. After joining duty he/she will have to produce Medical Fitness Certificate issued by Govt. recognized Medical Board.
4. The appointment is subject to Police Verification and he/she will be dismissed from service if any adverse report is found against him/her with immediate effect.
5. After joining duty he/she will have to take oath an allegiance of affirmation to the Constitution of India in the prescribed form.
6. On joining, the appointee shall have to serve for a minimum period of 05 (five) years at the place of posting.
7. The seniority of the appointee shall be based strictly on merit list.
8. The appointment order shall be cancelled if the appointee directly or indirectly campaign for change of posting place or does not join within 30 (thirty) days from the date of issue of this order at posting place.
