**ORDER**

Miss Smiti Nayami Kadu is hereby engaged as A/T (Hum/Hindi/So-&Maths) on contract basis in the fixed pay of Rs.7200/- (Rupees seven thousand two hundred) only with effect from the date of joining in the concerned school up to 15-04-10 against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan.

The engagement is subject to the following conditions: -

- e) The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- f) No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule as per terms and condition mentioned in the agreement copy.
- g) During contract service period he/she is not entitle for medical reimbursement; winter allowances; children educational allowances; reimbursement of tuition fees; leave travel concession (LTC); special compensatory allowances etc.
- h) The contract teacher has to report his/her duty at posting place within 7 (seven) days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- e) He/she is not entitled to subscribe GPF or CGEIS or such other schemes during the period of services.
- f) The engaged teacher is also to work as volunteer instructor for TLC programme for the interest for the interest of literacy in /runachai Pradesh, in addition to his/her normal duties.
- g) No representation will be accepted for change of posting place.
- h) He/she will have to under go DIET training at concern DIET for Training as and when call for
- i) The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced from time to time.
- j) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
