Dated Itanagar, the 4th March, 2014.

Ms. Ozer Pertin is hereby appointed temporarily to the post of Trained Graduate Teacher (History) in the Pay Band-2 of Rs.9300-34,800 + GP-Rs.4600/-P.M. plus other allowances as admissible under rules from time to time with effect from the date he/she actually reports for duties to the Principal, Govt. Higher Secondary School, Borguli, E/Siang District, Arunachal Pradesh.

The appointment is made vice Sri P. Muhanta, TGT(Hist.) promoted to PGT(History).

The appointment is subject to the following conditions :-

- (i) The Appointee shall be on probation for a period of 2(two) years w.e.f. the date of joining and his/her seniority will be fixed as per overall merit.
- (ii) The appointment is purely on temporary and may be terminated at any time by giving 1(one) month notice without assigning any reason thereof. If he/she want to resign, he or she may do so after giving 1(one) month notice or by surrendering 1(one) month salary
- (iii) The regularisation of service shall be considered on completion of probationary period subject to satisfactory performance of duty in his/her initial place of posting.
- (iv) After joining duty, he/she shall have to take an oath of allegiance of affirmation to the Constitution of India in the prescribed form.
- (v) He/She shall have to produce Medical Fitness Certificate from an authorised Medical Officer.
- (vi) The appointment is subject to the Police Verification and he/she will dismissed from Government service if any adverse report is there with immediate effect.
- (vii) He/She shall remain in the place of posting for a minimum period of 3(three) years from the date of joining. No representation/campaigning for the change of posting place shall be entertained before completion of 3(three) years of service in the initial place of posting.

Other terms & conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.
