The terms and conditions of appointment are as follows: -

- The appointment is purely temporary and may be terminated at any time after giving one month notice from either side without assigning any reason. Appointing authority however reserves the right of terminating the services of the appointees forthwith or before the expiry of the stipulated period of the notice by making payment to him/ her a sum equivalent to the pay and allowances for the period of notice. If the appointee wishes to resign from services or fails to give one month clear notice as above he/ she has to pay one month salary in lieu of the 1 (one) month notice period.
- The appointees shall be on probation for a period of 2 (two) years from the date of joining to the post.
- The appointment carries with the liabilities to serve in any Govt. Higher Secondary/ Secondary School of Arunachal Pradesh.
- Other conditions of service will be subject to his/ her being found fit on verification of character and antecedents.
- The appointees shall join the school within 1st June'2020 to 10th June'2020 positively failing which his/ her appointment order shall automatically stand cancelled.
- Their seniority will be fixed as per the merit result declared by the APPSC, Itanagar.

The appointment will be further subject to: -

- Production of medical fitness certificate from the Medical Board, appointed/ authorized by the Govt. of Arunachal Pradesh.
- Production of the release order/ NOC from the previous employer (applicable in the case of persons who are already in Govt. service).

3. If any given or information furnished by the candidate proves to be false and if the candidate is found to have wilfully suppressed any material fact, he/ she will be liable to be removed from service/ discharged from probation and such other action may be taken by the Govt. as deem fit.

4. No travelling allowances will be allowed for joining the place of posting.
