Dear Smti Rinku Upadhya,

With reference to your application dated 25/08/06 and the discussions with the undersigned, I am pleased to inform you that you are selected for appointment as a Contractual Teacher in Kasturba Gandhi Balika Vidyalaya subject to the following terms and conditions

1. You will be posted in the KGBV at Boleng in Boleng Block, Dist East Siang, Arunachal Pradesh.
2. Your appointment will be with effect from the date of your joining on duty in the school.
3. The appointment will be purely on temporary and contractual basis for a period of one year or the end of the current academic session whichever ever is earlier. The continuation thereafter is conditional.
4. You will be paid a consolidated monthly honorarium of Rs 3500/- (Rupees three thousand five hundred) only. This amount shall remain fixed for all consecutive years and there will be no increments.
5. You are required to stay in the school campus with the limited facilities available looking after the girls and working for their all-round development.
6. You will abide by all the rules and regulations of the school and all the associated agencies as on today and issued from time to time and the instructions of the head of the institution and all the superior authorities.
7. You will attend the meetings and undergo the trainings whenever/ wherever organized and asked to. You will also be ready to move on transfer / deputation to other schools wherever and whenever required.
8. Your conduct in the school as well as outside must be in accordance with the high esteem of the institution / organization and no compromise will be allowed in this regard.
9. This organization does not guarantee your services and cannot be held responsible if at any time the project gets discontinued and/or you are required to leave the services.
10. In violation of any of the terms and conditions mentioned above, you will be disqualified for the job and this office reserves the right to terminate your services at any time with out assigning any reason thereof.

If you agree to all these terms and conditions, kindly accept the appointment by signing a copy of this letter and proceed to the school mentioned to join on duty there latest by 01, 2006.

ORDER

Consequent upon the board recommendation the service of Shri/Smt./Miss Rinkoo Devi is hereby allowed to continue as Headmistress on Contractual basis against the KGBV Pasighat, Sarva Shiksha Abhiyan Mission East Siang District at fixed salary/ Honorarium of Rs. 25000/- (Rupees Twenty five thousand) only per month for a period of 1 years i.e upto 31st March 2017 . Further extension of His/her engagement period will be subject to his/her satisfactory performance.

The engagement is subject to the following conditions:-

- Their contractual Service is purely temporary and shall be considered for continuation on the basis of performance and approval of salary in subsequent PAB.
- The contract Headmistress has no right to claim for regular appointment/ regularization of the post after expiry of contract engagement.
- No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditions mentioned in the agreement copy.
- During contract service period he/she is not entitle for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); Special compensatory allowances etc.
- The Second party shall be entitled for drawl salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, Bridge course and any other departmental engagement.
- The contract Headmistress have to report his duty at posting place within 7 (seven) days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- He/She is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract services.
- No representation will be accepted for change of posting place.
- He/She will have to under go DIET training at concern DIET for Training as and when call for.
- The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced from time to time.
- The engaged Headmistress has to sign an agreement for contract engagement before receiving this engagement order.
- The contract service shall be terminated by the undersigned on receipt of substantive complaint from the concerned DC/ DDSE/ NGO of the district.
- He/She should obtain professional training Certificate of B.Ed through distance mode from IGNOU or any other recognized Institute at his/her own cost within the period of two years from the date of appointment. Failure to obtain the same shall entail termination from the contractual service without prior notice.
- The mark sheets/Certificate submitted by them for consideration are subject to verification from original source. In case of the forged Mark sheets/ Certificates, they are liable to be punished as per rule.


