**ORDER**

In pursuance of SPD, Itanagar letter NO. AR/SSA/VER/2015-16(Pt-1) DTD. 12<sup>th</sup> May/2017 Ms Mariya Hanglung Tikhak is hereby engaged as Part Time Instructor (Work Education) on contract basis in the fixed pay of Rs. 12,809/- (Rupees twelve thousand eight hundred nine) only per month with effect from the date of joining in the School against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. She is posted at Govt. Upper Primary School, Laktong.

**The engagement is subject to the following conditions:-**

- a) The contract service has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- b) No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule as per terms and condition mentioned in the agreement copy.
- c) During contract services period he/she is not entitle for medical reimbursement , winter allowances, children educational allowances, reimbursement of tuition fees, leave travel concession(LTC), special compensatory allowances etc.
- d) The contract service have to report his/her duty at posting place within 7(seven) days failing which his/her engagement order will be automatically be treated as cancelled.
- e) He/She is not entitled to subscribed GPF or CGEIS or other schemes during the period of contract services.
- f) No representation will be accepted for changing of posting place.
- g) The employee has to sign an agreement for contact engagement before receiving this order.
- h) The other terms and conditions of services which are not specified shall be governed by the relevant rules and orders in forced time to time.
- i) The contract service shall be terminated by the undersigned on receipt of substantive complaint.


