O R D E R

Consequent upon the board recommendation the service of Shri/Smt./Miss **Matil Moyong** is hereby allowed to continue as Full time Teacher on Contractual basis against the KGBV Pasighat, Sarva Shiksha Abhiyan Mission East Siang District at fixed salary/ Honorarium of Rs. 20000/- (Rupees Twenty Thousand) only per month for a period of 1 years i.e upto 31st March 2017. Further extension of His/her engagement period will be subject to his/her satisfactory performance.

The engagement is subject to the following conditions:-

- a. Their contractual Service is purely temporary and shall be considered for continuation on the basis of performance and approval of salary in subsequent PAB.
- b. The contract Full time teacher has no right to claim for regular appointment/ regularization of the post after expiry of contract engagement.
- c. No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditions mentioned in the agreement copy.
- d. During contract service period he/she is not entitle for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); Special compensatory allowances etc.
- e. The Second party shall be entitled for drawl salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, Bridge course and any other departmental engagement.
- f. The contract Full time teacher have to report his duty at posting place within 7 (seven) days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- g. He/She is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract services.
- h. No representation will be accepted for change of posting place.
- i. He/She will have to under go DIET training at concern DIET for Training as and when call for.
- j. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced from time to time.
- k. The engaged Full time Teacher has to sign an agreement for contract engagement before receiving this engagement order.
- l. The contract service shall be terminated by the undersigned on receipt of substantive complaint from the concerned NGO/ DDSE/ DC of the district.
- m. He/She should obtain professional training Certificate of B.Ed through distance mode from IGNOU or any other recognized Institute at his/her own cost within the period of two years from the date of appointment. Failure to obtain the same shall entail termination from the contractual service without prior notice.
- n. The mark sheets/Certificate submitted by them for consideration are subject to verification from original source. In case of the forged Mark sheets/ Certificates, they are liable to be punished as per rule.


